Gordy noted in the four years of this voluntary donation that the club has raised \$30,000 for these improvements. Grounds Projects Update: The irrigation installation project has begun and should take between 9-12 days to complete with minimal disruption for the golfers. The entire course will be rewired and trenched. There will be all new control boxes. The system will be designed so that it will be pre programmed for usage.
